Puppy List Application Form

I/we wish to apply for inclusion on the Tibetan Terrier Breeder and Owners Club (TTBOC) Puppy list.

I/we agree to the following terms.

1. All applicants should be fully paid up members of the TTBOC.
2. The parents of the litter bred hold a current, clear BVA/KC eye certificate.
3. The parents of the litter bred hold a BVA hip score certificate which is ideally the breed mean score or less (or overseas equivalent).
4. The parents of the litter bred have been DNA tested for all conditions currently recorded on by the breed club and that no **two** genetically affected/carriers have been bred together.
5. The bitch was over the age of eighteen months at the time of mating.
6. A period of at least twelve months has elapsed since the bitch's previous litter.
7. All applicants shall agree to help with re-homing any dogs bred by them should the situation arise.
8. All applicants shall provide a contract with each sale in keeping with current Kennel Club guidelines, part of which includes: *In order to ensure that the KC will uphold an endorsement it is essential that the endorsement is placed correctly. The main points are that the endorsement must be in place before the new owner takes the puppy home and it must be drawn to their attention, in writing, so they are fully aware of the implications before they buy the puppy. The most effective way of ensuring this is to ask the puppy buyer to sign and date a contract with the breeder to the effect that they are aware of and accept the terms of the endorsement. A copy of the contract should be kept by the breeder and a copy given to the new owner for future reference. This essential requirement is referred to on the Form 1 (Application for Litter Registration) and full details are given in Appendix 1. Full details from the KC.*
